These Local Rules are in addition to the EGA Local Rules & Terms of Competition as stated in the 2024 Hard Card.

### **LOCAL RULES**

#### 1. OUT OF BOUNDS (R. 18-2)

- Beyond any wall or fence defining the boundaries of the course.
- Both sides of the 1st hole and behind the green.
- Behind the 3<sup>rd</sup> green.
- The left side of the 7th hole.
- The par 3 course and practice area on the left side of the 9th hole.

#### 2. ABNORMAL COURSE CONDITIONS (R. 16)

- Artificially surfaced (paved or concrete) paths and roads, including their adjacent artificial borders, ditches and sleepers, shall be considered the same obstruction.
- MLR F-6 is in effect: relief is not allowed if only interferes with the players stance in these conditions:
  - Animal holes
  - Liners inside areas with woodchip or mulch.

#### 3. IMMOVABLE OBSTRUCTIONS CLOSE TO PUTTING GREEN (MLR F-5.2 is in effect)

• This local rule only applies when both the ball and the obstruction are in the general area cut to fairway height or less

#### 4. INTEGRAL OBJECTS

• Any path (even gravel surfaced) except those paved or concrete.

#### 5. NO PLAY ZONE ON HOLE 7. (MLR E-8.1)

 The turf nursery on the left side of the 7th hole defined by blue stakes is a NO PLAY ZONE that is treated as an abnormal course condition. Free relief MUST be taken from interference by the no play zone under Rule 16.1f.

# 6. Exception to EGA Terms of Competition electric trolleys are allowed for the duration of the Championship.

**NOTES:** Penalty areas in holes 14th, 15th and 16th painted in yardage books do not exist. These areas are part of the general area. In case of being considered necessary, players should play a provisional ball.

## **EVACUATION PLAN**

When play is suspended by the Committee for a dangerous situation, if the players in a match or group are between the play of two holes, they shall not resume play until the Committee has resumed play. If they are in the process of playing a hole, they shall discontinue play immediately and shall not thereafter resume play until the Committee has resumed play. If a player fails to discontinue play immediately, she shall be disqualified unless circumstances warrant waiving such penalty as provided in Rules.

The signal for suspending play due to a dangerous situation will be the following notes of siren or similar **Discontinue Play Immediately**: One prolonged note of siren.

**Discontinue Play:** Three consecutive notes of siren, repeated (players may only complete the hole they are playing).

**Resume Play:** Two short notes of siren, repeated.

#### Plan of Evacuation

In case of evacuation of the course, the players must go to the nearest point marked below and wait for instructions. Also, the players must pay attention to return to these collection points.

Collection Points: 1, 2, 3, 4

- 1 Holes 1, 4, 5, 8, 9, 10, 11, 18, Club House
- 2 Holes 12, 14, 15, 16, and 17 Tee of hole 12 (Wooden Shelter)

3 - Holes 2, 3, 6, 7, Green of 12, 13, Tee of Hole 7 (Toilets)
